Subject: 2019-2020 Division and Club Recognition

Issue: Kiwanis International has delegated division and club Recognition to the districts beginning in

this administrative year. District Board needs to decide whether to have a program in place

Discussion: Kiwanis International has historically handled division and club recognition through a

distinguished awards program over the last several decades. However, in recent years, the criteria changed on an annual basis and in one year, there was no program at all. Kiwanis International Board decided to delegate this function to the districts and determine the means and methods of recognition. If our district desires to have a program, it should be announced at the beginning of the 2019-2020 administrative year to give clubs time to adjust their goals and objectives for this year to meet the criteria if they so desire.

To facilitate that process, the Board should approve a new division and club recognition program. The method of recognition does not have to be determined immediately, but the criteria should be set now.

The current 2018-2019 division and club recognition program administered by Kiwanis International is as follows:

DIVISION RECOGNITION (must have at least five clubs in good standing)

- Open at least 1 new club in the division; OR
- Achieve a net increase in membership for at least two-thirds of the existing clubs

CLUB RECOGNITION (must complete three of 4)

- Membership and Education Net increase in membership; OR sponsorship of a new Kiwanis club
- Community Impact Completion of a signature project; AND sponsorship of at least one Service Leadership Program club.
- Our Kiwanis Image Participation of president and secretary in Club Leadership Education training.
- Financial Viability Per-member donation to the Kiwanis Children's Fund (defined by either US\$10 per member or tiered by district/region).

Kiwanis International has proposed guidelines for the district to use in deciding whether to have a division and/or club recognition program. For recognizing distinguished Kiwanis divisions, the recommended criteria should reflect growth within the division, including:

- Net gain in membership in the division.
- Opening of a new club within the division.
- Increase in new members by clubs in the division.

For recognizing distinguished clubs, the recommended criteria should include:

- Increase in membership by the club.
- Completion of a signature project by the club.
- Participation by the club president-elect and officers-elect in club officer education.

- Sponsorship/support of Service Leadership Programs.
- Annual financial support of the Kiwanis Children's Fund/The Eliminate Project or other national/district Kiwanis foundations.
- Sponsorship of a new Kiwanis club in Africa.

Recommendation: Continuation of a distinguished division and club recognition program with criteria established by the Capital District as follows:

DIVISION RECOGNITION (must have at least five clubs in good standing)

- Open at least 1 new club in the division; OR
- Achieve a net increase of +2 membership for at least two-thirds of the existing clubs

CLUB RECOGNITION (must complete all)

- Membership net increase in +2 membership; OR sponsorship of a new Kiwanis club
- Participation of president and secretary in Club Leadership Education training (in person or on-line)
- Community Impact Completion of a signature project by the club;
- Service Leadership Program sponsorship sponsorship of at least 1 Service Leadership Program club or contribution to Kiwanis Outreach program.
- \$10 per-member donation to the Kiwanis Children's Fund (combined club and individual member contribution) and \$3 per member to the Capital District Kiwanis Foundation
- Submission of all monthly and club election reports

Forward Work: If approved, the following actions are assigned:

- Secretary Treasurer provide criteria and information to Lt. Governors and District Editor for distribution, copy Board of Trustees and Other District Committee Chairs
- Lt. Governors provide criteria and information to clubs
- District Editor publish information on District Web Site and next Capital Kiwanian

Subject: 2019-2020 Awards Program

Issue: Need to revitalize current program and provide additional recognition opportunities to clubs

and members during the 2019-2020 administrative year.

Discussion: Club and member recognition programs have received little or no attention in the last several

years in the District and many have been discontinued. In addition, Kiwanis International has discontinued a number of recognition programs over the years including Distinguished Clubs. Currently, there is only one planned International club recognition program remaining – The Signature Club Project and one on the district level – the Distinguished Club member program.

A number of districts have stepped up to fill the void and provide additional recognition

opportunities.

Provided the Board has approved Distinguished Club Award program in Action Item # 1 – that will give us just two opportunities for club or member recognition. However, there should be additional opportunities used by the district to recognize the work of our clubs throughout the district. If our district desires to have a program, it should be announced early enough in the 2019-2020 administrative year to give clubs time to adjust their goals and objectives for this year to meet the criteria for the awards if they so desire.

To facilitate that process, the Board should approve a new division and club recognition program. The method of recognition does not have to be determined immediately, but the awards should be now and the criteria developed and released as soon as possible in the fall of 2019.

Recommendation: Expansion of club and individual recognition program in the district with the following awards. Each award proposed will have appropriate recognition included along with the number of recipients. Those awards based on club size are divided into the following categories:

- o Gold Division 101 members or more
- Silver Division 71 to 100 members
- Orange Division 46 to 70 members
- o Blue Division 31 to 45 members
- White Division 30 members or less

Criteria for the awards shall be developed and approved at the November Board meeting and then distributed across the district.

- Club of the Year 1 Overall Winner and 4 honorable mentions
- Achievement 1 first place & 3 honorable mentions per size category
- Aktion, Builders Club and K-Kids Sponsorship 1 first place & 3 honorable mentions per size category
- CKI Sponsorship recognition provided by Capital District CKI
- Club Membership Growth All clubs with net growth of 5 or more receive a banner patch
- Club Newsletter 1 first place & 3 honorable mentions per size category
- Club Service 1 first place & 3 honorable mentions per size category
- Club Public Relations and Social Media 1 first place and 3 honorable mentions per size category
- Interclub 100% Member Participation -- clubs with 100% active members participating receive award
- Interclub 1 first place & 3 honorable mentions per size category
- Key Club Sponsorship recognition provided by Capital District Key Club
- Support of Human & Spiritual Values 1 first place & 3 honorable mentions
- Outstanding Membership Growth Award (Net) Club with greatest net growth receives award (new clubs not eligible)
- Outstanding Membership Growth Award (%) Club with greatest % growth receives award (new clubs not eligible)
- Grow to 20 clubs with less than 20 members achieve net growth to 20 or more members receive award

Proposed individual awards

 Distinguished Kiwanian – No Limit – awarded based on district criteria (continuation of current program)

Other awards (to be selected by Governor)

- Outstanding District Trustee
- Outstanding Lieutenant Governor
- Outstanding District Chair
- Special Service
- Most Improved Division Award

Forward Work: If approved, the following actions are assigned:

- Immediate Past Governor as part of the Achievement Committee, prepare an integrated awards document to be reviewed by District Board at the November 2019 Board meeting
- District Committee Chairs provide input to Achievement Committee for award criteria for their area
- Governor, Governor-elect, Secretary-Treasurer, Immediate Past Governor and 2 other at large members appointed by the Governor to serve as special committee to provide input to Achievement Committee for all other awards not covered by District Committee Chairs
